I. CALL TO ORDER, INTRODUCTIONS

Chair Nancy Wideman, noting the presence of a quorum, opened the meeting at 10:13 a.m. and asked for introductions.

II. APPROVAL OF THE AGENDA

Chair Wideman asked for approval of the meeting agenda.

ACTION:

Lois Nevins moved and Dick Bailar seconded a motion to approve the agenda. The motion passed unanimously.

III. APPROVAL OF THE JANUARY 15, 2015 MINUTES

Chair Wideman asked for approval of the January 15, 2015 meeting minutes.

ACTION:

Carol McQueen moved and Mr. Bailar seconded a motion to remove Brenda Graham, Sandy Beach and Dawn Taylor from Members Present, to add said members to Members Absent and to approve the January 15, 2015 minutes as amended. The motion passed unanimously.

IV. OLD BUSINESS

- A. Committee Reports
 - 1. Financial Committee Reports
 - a. Monthly Financial Report Review and Approval

Steven Dopp presented the monthly financial report for December 2014.

ACTION:

Ms. McQueen moved and Lisa Frieman seconded a motion to approve the monthly financial report for December 31, 2014 as circulated. The motion passed unanimously.

- B. Staff Items
 - 1. Fiscal Year 2013-14 Florida Department of Economic Opportunity Grant
 - a. Final Report

Mr. Dopp stated that the Final Report for the Regional Rural Development Grant had been transmitted to the Department. He stated that the Task Force has completed all deliverables contained in the scope of work.

2. Staff Report on Fiscal Year 2014-15 Florida Department of Economic Opportunity Regional Rural Development Grant Application

Mr. Dopp stated that the Task Force has received an award letter from the Department for its \$150,000 Regional Rural Development grant. He further noted that the Department has requested a revised Scope of Work and budget for the grant application. Mr. Dopp distributed copies of a draft revised Scope of Work and budget for consideration by the Task Force.

ACTION: Lisa Frieman moved and Mr. Bailar seconded a motion to accept the revised Scope of Work, the revised budget, and to submit the revised Scope of Work and budget to the Florida Department of Economic Opportunity. The motion passed unanimously.

a. Revamp Website

Mr. Dopp noted that no action has been taken on this deliverable.

b. Five-Year Strategic Marketing Plan

Mr. Dopp stated that no action has been taken on this deliverable.

c. American Express Destination Insights - International Version

Mr. Dopp reported that the U.S. Travel Association is no longer offering the American Express Destination Insights report and that the report must now be purchased directly from American Express. Mr. Dopp is awaiting a response from the U.S. Travel Association regarding the purchase of the report from American Express.

d. Brochure Distribution

Mr. Dopp noted that the Task Force has contracted with two brochure distribution companies for 2015. He stated that Florida Suncoast Tourism Promotions, Inc., will distribute Task Force brochures at AAA Auto Club offices statewide; along I-10 from Marianna to I-75; U.S. Highway 19 from Tallahassee to Tampa Bay; I-75 from Lake City to Venice; and I-4 from Tampa to Haines City, including Polk County. He further noted that the Task Force is entering into an agreement with Ad-Rack, a division of Helinger Advertising, to distribute brochures along I-75 from East Ridge, Tennessee to Jennings, Florida.

e.. Professional Enhancement Scholarships

Mr. Dopp noted that no action has been taken on this deliverable.

f. Media Advertising - Florida Pocket Ranger App Advertisement

Mr. Dopp reported that the Task Force has entered into a one-year contract with Parks by Nature Network, Inc. for a banner advertisement to run for one year on the app. He stated that the banner advertisement appears when searching by Florida Parks District 2 and when searching by either the Fishing or Biking activities. He further noted that tapping on the banner advertisement takes the user to the mobile version of the Task Force website. He noted that tapping on the banner advertisement when searching by the Fishing activity, takes the user to the Task Force's Fish Natural North Florida website.

3. American Express Destination Insights Fourth Quarter 2014 Report

Mr. Dopp distributed copies of the report to Task Force members. He stated that this was the last report which will be received under the current contract with the U.S. Travel Association.

ACTION:

Mr. Bailar moved and Ms. Nevins seconded a motion to authorize payment of a stipend to Mr. Loog in the amount of \$200 per travel day up to a maximum of \$10,000 for his work in managing the Visit Florida - North Central Florida Rural Area of Opportunity grant. The motion passed unanimously.

1. Suwannee River Wilderness Trail Paddling Guide Update

Mr. Dopp noted that staff has completed incorporating Task Force member revisions into the paddling guide. He requested the Task Force resolve the issue regarding whether to provide credit to Lars Anderson for his role in writing the text for the guide and whether the oddnumbered pages should be rotated 180 degrees.

ACTION:

Ms. McQueen moved and Mr. Bailar seconded a motion to not provide an authorship credit in the paddling guide. The motion passed unanimously.

ACTION:

Ms. McQueen moved and Mr. Bailar seconded a motion to rotate the oddnumbered pages 180 degrees and to bind the document on its left side. The motion passed unanimously.
